7	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council tha
8	it hereby authorizes Nation's Chairwoman Vivian Juan-Saunders, Legislative Counci
9	Chairperson Evelyn Juan Manuel, and Legislative Council Representative Timothy
10	Joaquin to attend and serve as the Tohono O'odham Nation's delegation to the
11	National Congress of American Indians 63 <sup>rd</sup> Annual Session.
12	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes
13	Chairwoman Vivian Juan-Saunders as the Tohono O'odham Nation's voting delegate
14	and Legislative Council Chairperson Evelyn Juan Manuel to serve as alternate voting
15	delegate to the National Congress of American Indians 63 <sup>rd</sup> Annual Session.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes
17	payment of \$5,000 for NCAI membership dues for the Tohono O'odham Nation.
