(Approves the Authorization of San Xavier District to Continue its Government Operations
Pending Final Approval of its FY07 Budget)

RESOLUTION NO. 06-605

1 **WHEREAS, the San Xavier District is unable to forward its FY07 approved budget to the Tohono**
2 **O'odham Legislative Council (TOLC) for review and approval before the end of the**
3 **current fiscal year; and**

4 **WHEREAS, it is in the best interest of the San Xavier District (District) to continue its fiscal year**
5 **operations pending the review and approval of its FY07 budget; and**

6 **WHEREAS, the San Xavier District has sufficient funds in its treasury to cover all expenditures**
7 **during this interim period.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
9 **the authorization of the San Xavier District to continue governmental operations**
10 **until the final approval of its FY07 budget by November 30, 2006.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
12 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
14 **Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
15 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat. 984).**


