1 **WHEREAS, by Resolution Number 06-212, the Tohono O'odham Legislative Council approved the**  
2 **FY2007 Bureau of Indian Affairs (BIA) budgets and Annual Funding Agreement under**  
3 **a P.L. 93-638 Master Contract; and**

17 **WHEREAS, the carry forward savings will be used for operational costs not covered under the FY**  
18 **2007 BIA Social Services Budget, including Indirect Cost; and**

19 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY2007 BIA**  
20 **Social Service/Family Assistance use of carry forward savings in the amount of**  
21 **\$134,627.13.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 23 **1. It hereby approves and authorizes the FY2007 BIA Social Services/Family**  
24 **Assistance, carry forward savings in the amount of \$134,627.13 and authorizes**  
25 **expenditures in accordance with the attached budget.**
- 26 **2. That the Tohono O'odham Nation's official to wit: The Chairwoman, and any**  
27 **designated official are hereby authorized to negotiate and execute the grant**  
28 **provided however that any amendments affecting the funding levels of this**  
29 **contract shall be submitted for further prior approval by the Tohono O'odham**  
30 **Legislative Council.**




