

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Arizona Long Term Care Services (ALTCS) Fiscal Year 2007 Four Month
Budget October 1, 2006 – January 31, 2007)

RESOLUTION NO. 06-609

1 WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State of
2 Arizona to provide Arizona Long Term Care Services (ALTCS) Case Management
3 services to eligible enrolled members; and

4 WHEREAS, the Tohono O'odham Nation has provided ALTCS case management services since
5 June 1996 and is reimbursed from the State of Arizona for the services; and

6 WHEREAS, the attached Arizona Long Term Care Services (ALTCS) Program fiscal year 2007 Four
7 month budget \$102,855.33 with the 2.5 percent employee salary adjustment has been
8 prepared in accordance with the FY 2007 Budget Development Instructions; and


9 WHEREAS, all future Arizona Long Term Care Services (ALTCS) Program client reimbursement
10 funds obtained by the Division of Senior Services shall be applied to the Arizona Long
11 Term Care Services (ALTCS) base budget for current and future program operations.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
13 approves:

- 14 1. The Arizona Long Term Care Services (ALTCS) Program fiscal year 2007 four
15 month budget of \$102,855.33 which also includes the 2.5 percent salary
16 adjustments.
- 17 2. All future Arizona Long Term Care Services (ALTCS) Program client
18 reimbursement funds obtained by the Division of Senior Services shall be
19 applied to the Arizona Long Term Care Services (ALTCS) Program base budget for
20 current and future program operations.
- 21 3. The Tohono O'odham Nation's officials to wit: the Chairwoman and any
22 designated official are hereby authorized to negotiate and execute the grant,
23 provided however, that any amendment affecting the funding or funding levels
24 of this contract shall be submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH, Day
27 of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-
28 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
29 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
30 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
32 Stat. 984).
