3	WHEREAS,	the Indian Self-Determination and Education Assistance Act, P.L. 93-638, gives the
4		Tohono O'odham Nation the right to negotiate the contracting of additional
5		programs, functions, services and activities from the Indian Health Service; and
6	WHEREAS,	the Tohono O'odham Department of Human Services proposes to contract the
7		Diabetes Prevention Program from the Indian Health Service Sells Service Unit; and
8	WHEREAS,	the proposed contract period is from October 1, 2006, until the termination of the
9		Master Contract; and
10	WHEREAS,	the proposed contracted Diabetes Prevention Program shall be placed under the
11		Division of Health Promotion, as the TohonoO'odhamPromotionLifelongActivityformula and the Colombian Colomb
12		Youth Program (T.O. PLAY).
13	NOW, THER	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
14		1. Approves the Tohono O'odham Department of Human Services proposal to
15		contract the Diabetes Prevention Program from the Indian Health Service Sells
16		Service Unit.
17		2. Approves the proposed contract period as of October 1, 2006 until the
18		termination of the Master Contract, which start-up date may be adjusted as
19		agreed to by the Nation and the Indian Health Service.
20		3. Approves the allocation of funds through PL 93-638 to fund the activities of the
21		T.O. P.L.A.Y. program as stated in the proposed contract.
22		4. Authorizes the proposed budget for Division of Health Promotion, which is
23		amended to include funds that have been contracted through PL 93-638, to
24		provide diabetes prevention and education throughout the Tohono O'odham
25		Nation.

5. The Tohono O'odham Nation Officials, to wit: the Chairwoman and any

of the contract shall be submitted for further approval.
