RESOLUTION NO. 06-615

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with Legislative powers that**
2 **includes fiscal powers to adopt, approve, and amend annual budgets and to**
3 **authorize the expenditure of such funds; and**

4 **WHEREAS, the Nation's districts council can expend district funds pursuant to budgets**
5 **authorized under resolution of the district council's and approved by the Tohono**
6 **O'odham Legislative Council; and**

7 **WHEREAS, the San Lucy District enacted Resolution No. SL 09-62-06 "Approving Continuing**
8 **Operations of San Lucy District Pending Approval of the FY 2007 Budget" and in**
9 **addition is requesting for approval by the Tohono O'odham Legislative Council; and**

10 **WHEREAS, it would be in the best interest of San Lucy District to continue district operations**
11 **pending approval of the district's FY 2007 Budget.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council that it hereby**
13 **authorizes San Lucy District to continue district operations until approval of the FY**
14 **2007 Budget.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH. Day**
16 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
