1 **WHEREAS, Sells District Chairman presented the Sells District FY - 2007 Budget to the Tohono**
2 **O'odham Legislative Council for review and approval; and**


3 **WHEREAS, the FY-2007 Budget in the amount of One Million, Ninety Four Thousand, Six Hundred**
4 **Ninety Dollars and Ninety - Four cents (\$1,094,690.94) covers the cost for the District**
5 **Administration and includes the four communities; Sells, Big Fields, Cowlic and**
6 **North Communities in the amount of \$30,000.00 per community at which the grand**
7 **total is One Million, Ninety Four Thousand, Six Hundred Ninety dollars and Ninety-**
8 **Four cents (\$1,094,690.94); and**

9 **WHEREAS, the Tohono O'odham Legislative Council did review and approve the Sells District**
10 **Administration Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Sells District's FY - 2007 Budget in the amount of \$1,094,690.94 as attached hereto.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH. Day**
14 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,078.0 FOR; 169.0**
15 **AGAINST; 193.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**
