

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing and Appropriating Funding for Financial Assistance Request to attend the
National/International Native American Alcoholics Anonymous Conference)

RESOLUTION NO. 06-617

1 **WHEREAS, members of the Tohono O'odham Nation respectfully request assistance in receiving**
2 **funding to attend the National/International Native American A.A. Conference which**
3 **will be held in Green Bay, Wisconsin from September 28, 2006 through October 1,**
4 **2006; and**

5 **WHEREAS, Daniel L.A. Preston, San Xavier District Member request financial assistance in the**
6 **amount of \$172.00, Marcine A. Lopez, Sells District member request financial**
7 **assistance in the amount of \$907.41 and Marisa Sakurai, Chukut Kuk District**
8 **member request financial assistance in the amount of \$ 982.41; and**

9 **WHEREAS, the benefits of attending the conference will greatly assist in their recovery, while**
10 **holding a special part of who they are as Native Americans; and**

11 **WHEREAS, the support of other Native Americans is of great benefit and importance because the**
12 **journey of recovery can be a lifetime struggle; and**

13 **WHEREAS, sobriety is a less common goal among the Tohono O'odham and by attending this**
14 **conference will further strengthen our spirit of hope in the path to sobriety; and**

15 **WHEREAS, by attending the conference this will allow the attendees to grow as an individuals,**
16 **thus benefitting family, friends, community and the Tohono O'odham Nation.**

17 **NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council hereby**
18 **authorizes and appropriates financial assistance to attending the**
19 **National/International Native American A.A. Conference for Daniel L.A. Preston,**
20 **Marcine A. Lopez and Marisa Sakurai, members of the Tohono O'odham Nation.**

21 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby appropriates**
22 **from the Nation's Surplus Funding the total amount of \$2,061.82, to assist members**
23 **of the Tohono O'odham Nation to attend the National/International Native American**
24 **A.A. Conference which will be held in Green Bay, Wisconsin from September 28, 2006**
25 **through October 1, 2006 as requested herein: Daniel L.A. Preston, in the amount of**
26 **\$172.00, Marcine A. Lopez, in the amount of \$907.41 and Marisa Sakurai, in the**
27 **amount of \$ 982.41.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairwoman of the**
29 **Tohono O'odham Nation and/or any designated official are hereby authorized to**
30 **process and execute any necessary documentation to satisfy this appropriation.**


