

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing and Appropriating Surplus Funding for Financial Assistance Request**  
**for Members (Father and Son) of the Tohono O'odham Nation to Travel**  
**back to Minneapolis, Minnesota)**

RESOLUTION NO. 06-618

1 **WHEREAS, members of the Tohono O'odham Nation respectfully request financial assistance to**  
2 **travel back to Minneapolis, MN, where family has been living; and**

3 **WHEREAS, Mr. Prugh Jose, II and Prugh Jose III, Grandmother and Great Grandmother, passed**  
4 **away here on the Tohono O'odham Nation; and**

5 **WHEREAS, Prugh and his son live in Minneapolis with his family, fiancé and other children; and**

6 **WHEREAS, the father and son came back home to Sells, to pay their last respects to their**  
7 **grandmother and great-grandmother during her wake and funeral; and**

8 **WHEREAS, the family and Mr. Jose have not been able to financially pay for their trip back to**  
9 **Minneapolis to be with his family as planned; and**

10 **WHEREAS, Mr. Jose, is requesting for financial assistance with purchasing two one-way tickets**  
11 **to Minneapolis so Prugh and his son can reunite with their family.**

12 **NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council hereby**  
13 **authorizes and appropriates from Nation's Surplus Funding the total amount of**  
14 **\$468.60, to assist members of the Tohono O'odham Nation, namely Prugh Jose, II and**  
15 **Prugh Jose III to return back to Minneapolis, Minnesota.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairwoman of the**  
17 **Tohono O'odham Nation and/or any designated official are hereby authorized to**  
18 **process and execute any necessary documentation to satisfy this appropriation.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>. Day**  
20 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,164.0 FOR; -0-**  
21 **AGAINST; 276.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**




