

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2007 Budgets for the Baboquivari District and Six Communities)**

**RESOLUTION NO. 06-619**

1 **WHEREAS, at a regular scheduled meeting on September 11, 2006 the Baboquivari District**  
2 **Council did approve the gaming distribution in the amount of \$1,094,690.94; and**

3 **WHEREAS, the District Council allocated 40% to the district administration in the amount of**  
4 **\$437,876.38 and 60% to the six (6) communities in the amount of \$656,814.56, to be**  
5 **divided equally at \$109,469.09; and**

6 **WHEREAS, on September 11, 2006 the Baboquivari District Council did review and approve the**  
7 **FY 2007 Baboquivari District and six community budgets in the amounts as follows:**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
17 **approves the FY 2007 Baboquivari District and six community budgets in the amount**  
18 **of \$1,094,690.94 to be distributed with 40% to the District Administration (437,876.38)**  
19 **and 60% to the six (6) Communities (\$109,469.09 each) for a total of \$656,814.56 per**  
20 **attached budgets.**

21 **BE IT FINALLY RESOLVED that any additional monies from gaming distribution shall be brought**  
22 **forward for approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>. Day**  
24 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,779.75 FOR; 252.7**  
25 **AGAINST; 408.35 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**


