RESOLUTION NO. 06-622

1 WHEREAS, the Gu Vo District Governing Council did meet on September 06, 2006; and  
2 WHEREAS, the Gu Vo District Governing Council agreed for the continuation of the FY 2006 Gu  
3 Vo District Budget in order for the District Administration and it's Communities to  
4 Function; and  
5 WHEREAS, the Gu Vo District Governing Council has sufficient funds to continue the budget for  
6 the month of October 2006.  
7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
8 the request for the continuation of the Gu Vo District FY 2006 budget and that there  
9 are sufficient funds to cover expenditures beyond September 30, 2006.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>. Day  
11 of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
13 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat. 984).


