9	WHEREAS,	the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per						
10		Legislative Council Resolution No.06-307; and						
11	WHEREAS,	the Secretary of the Department of the Interior did approve the Third Per Capita						
12		Revenue Allocation plan on July 28, 2006; and						
13	WHEREAS,	Tohono O'odham Membership Services submits to the Tohono O'odham Legislative						
14		Council the Master List for Eligible Tohono O'odham Adult Members for review and						
15		approval for the Third Per Capita Distribution; and						
16	WHEREAS,	total eligible Tohono O'odham Adult Members for the Third Per Capita Distribution						
17		is 17,669 members; and						
18	WHEREAS,	disbursement of funds to each eligible adult Tohono O'odham member is contingent						
19		upon verification of a member and further certification by the Tohono O'odham						
20		Legislative Council.						
21	NOW, THEF	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves						
22		the Master List for Eligible Adult Tohono O'odham Members for the Third Per						
23		Capita Distribution; provided that:						
24		(1) Disbursement of a third per capita payment to each eligible adult Tohono						
25		O'odham member is contingent upon verification of a member's eligibility						
26		and further certification by the Tohono O'odham Legislative Council.
