

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Master List for Third Per Capita Distribution For Eligible Tohono
O'odham Minor Members)

RESOLUTION NO. 06-627

1 **WHEREAS, on June 28th, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per**
10 **Legislative Council Resolution No.06-307; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Third Per Capita**
12 **Revenue Allocation plan on July 28, 2006; and**

13 **WHEREAS, Tohono O'odham Membership Services submits to the Tohono O'odham Legislative**
14 **Council the Master List for Eligible Tohono O'odham Minor Members for review and**
15 **approval; and**

16 **WHEREAS, total Eligible Tohono O'odham Minor Members for the Third Per Capita**
17 **Distribution is 9,282; and**

18 **WHEREAS, approval of Eligible Tohono O'odham Minor Members for set-up of minor account**
19 **at Wells Fargo Bank is contingent upon Verification and Certification by the Tohono**
20 **O'odham Legislative Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **Master List for Minor Eligible Members for the Third Per Capita Distribution.**

23 **BE IT FURTHER RESOLVED that approval of Eligible Tohono O'odham Minor Members for set-up**
24 **of a minor account at Wells Fargo Bank is contingent upon Verification and**
25 **Certification by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH. Day**
27 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
