

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Rules of the Tohono O'odham Legislative Council)**

LEGISLATIVE ORDER NO. 06-635

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power to establish rules and procedures to regulate all meetings of**
3 **the Council and its standing committees (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 1(a) and (b)); and**

5 **WHEREAS, the Legislative Council has exercised this power by adopting and amending the**
6 **Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules")**
7 **(Legislative Order No. 06-460, re-adopting Legislative Rules); and**

8 **WHEREAS, the Legislative Rules Committee developed draft amendments to Articles I and II of**
9 **the Legislative Rules, ("September 2006 Legislative Rules Amendments"), which are**
10 **incorporated by this reference and are dated September 18, 2006; and**

11 **WHEREAS, while the Constitution of the Tohono O'odham Nation provides that "[i]f a**
12 **representative to the Tohono O'odham Council . . . is unable to attend a meeting, the**
13 **alternate of the representative shall attend," it is necessary to amend the Legislative**
14 **Rules to clarify when a Legislative Council representative who returns to a Legislative**
15 **Council session will replace his or her alternate (Constitution, Article XII, Section 1).**

16 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**
17 **adopts the September 2006 Legislative Rules Amendments.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 19TH. Day of**
19 **SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,024.3 FOR; 222.7**
20 **AGAINST; 193.8 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI Section 1(a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
