

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 06-603, "Authorizing Tohono O'odham Nation Delegation to the
National Congress of American Indians 63rd Annual Session")

RESOLUTION NO. 06-657

1 WHEREAS, the National Congress of American Indians ("NCAI") will hold its 63rd Annual
2 Session in Sacramento, California on October 2-6, 2006; and

3 WHEREAS, the Tohono O'odham Nation is a long-time member in good standing with the
4 National Congress of American Indians; and

5 WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in
6 the National Congress of American Indians; and

7 WHEREAS, it is necessary to amend the previous designation of the Nation's NCAI delegates
8 made by Resolution No. 06-603.


9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
10 it hereby amends Resolution No. 06-603 to

11 (1) Authorize Nation's Chairwoman Vivian Juan-Saunders, Legislative Council
12 Chairman Verlon Jose, Legislative Council Representative Timothy Joaquin and
13 Representative Gerald Fayuant to attend and serve as the Tohono O'odham
14 Nation's delegation to the National Congress of American Indians 63rd Annual
15 Session.

16 (2) Authorize Chairwoman Vivian Juan-Saunders as the Tohono O'odham Nation's
17 voting delegate and Legislative Council Chairman Verlon Jose to serve as alternate
18 voting delegate to the National Congress of American Indians 63rd Annual Session.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day
20 of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,543.3 FOR; -0-
21 AGAINST; 897.5 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
22 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).


