**10 Committee approval for the attached FY 2006 BIA Children's Home Program Budget**  
**11 Amendment #3, which adds \$100,000.00 WAG funding and increases salaries and**  
**12 fringe benefits cost-shares and indirect cost charges, to be effective October 1, 2005**  
**13 through September 30, 2006, in the following amounts:**


