

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Certification of Tohono O'odham Eligible Minor Member Listing**  
**for the Third Per Capita Payment)**

**RESOLUTION NO. 06-663**

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative") which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (Legislative Council**  
8 **Resolution No 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per**  
10 **Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Third Per Capita**  
12 **Revenue Allocation Plan on July 28, 2006; and**

13 **WHEREAS, the Tohono O'odham Enrollment Program submits to the Tohono O'odham**  
14 **Legislative Council the Certification Listing for eligible Tohono O'odham minor**  
15 **members for review and approval; and**

16 **WHEREAS, the current number of minors that have been verified for the Third Per Capita**  
17 **distribution is 5,309 members; and**

18 **WHEREAS, approval of eligible Tohono O'odham minor members for set up of minor account**  
19 **at Wells Fargo Bank is contingent upon verification by the Enrollment Program and**  
20 **certification by the Tohono O'odham Legislative Council; and**

21 **WHEREAS, pursuant to Resolution No. 06-627, the Legislative Council approved the Master List**  
22 **of Eligible Minors.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24 **Certification Listing for 5,309 eligible minors for the Third Per Capita payment.**

25 **BE IT FINALLY RESOLVED that approval of additional eligible Tohono O'odham minor members**  
26 **for set-up of minor accounts at Wells Fargo Bank is contingent upon the**  
27 **certification by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
29 **of SEPTEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat. 984).**


