

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Mr. Gary W. Braxton to the Tohono O'odham
Utility Authority Management Board)

RESOLUTION NO. 06-670

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to provide for, appoint or**
2 **provide for the appointment of, and prescribe the duties and powers of committees,**
3 **boards, officers and agents; to establish and regulate subordinate organization for**
4 **business purposes" (Article VI, Section 1(b) of the Constitution of the Tohono**
5 **O'odham Nation); and**

6 **WHEREAS, the Tohono O'odham Utility Authority of the Tohono O'odham Nation ("TOUA")**
7 **Second Restated Plan of Operation was adopted by Resolution No. 91-175; and**

8 **WHEREAS, the Plan of Operations requires that the Chairwoman of the Nation appoint Directors**
9 **to the TOUA Management Board, subject to approval by formal action of the**
10 **Legislative Council; and**

11 **WHEREAS, the Chairwoman of the Nation has determined that Mr. Gary W. Braxton is both**
12 **willing and qualified to serve on the TOUA Management Board and has nominated**
13 **Mr. Gary W. Braxton to serve on the TOUA Management Board; and**

14 **WHEREAS, TOUA Management Board or Directors "shall hold their offices until their successors**
15 **have been appointed and qualified..." (Plan of Operations Section 9.C.2.); and**

16 **WHEREAS, the Legislative Council Commerce Committee and Rules Committee have both**
17 **reviewed the Chairwoman's nomination in accordance with the Tohono O'odham**
18 **Nation Board Appointment Guidelines (Resolution No. 03-044).**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
20 **the Chairwoman's appointment of Mr. Gary W. Braxton to the Tohono O'odham Utility**
21 **Authority Management Board for a term commencing on the effective date of this**
22 **Resolution and expiring June 30, 2009, provided that Mr. Gary W. Braxton shall**
23 **continue to serve until replaced in accordance with terms of the Plan of Operations.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH, Day**
25 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,857.1 FOR; 169.0**
26 **AGAINST; 414.7 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


