

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Carryover of \$63,770.76 for the Tohono O'odham Nation Youth Council
FY-07 Budget)

RESOLUTION NO. 06-677

1 **WHEREAS, the Tohono O'odham Nation Youth Council was established by Tohono O'odham**
2 **Legislative Council Resolution No.95-216 for the purpose of serving as the official**
3 **voice of the Tohono O'odham Youth and administratively placed under the direct**
4 **supervision of the Department of Education; and**

5 **WHEREAS, the funds remaining in the FY06 budget will be carried over to fiscal year 2007 so the**
6 **Youth Council will continue to utilize the remaining funds for operational costs; and**

7 **WHEREAS, the Human Resources Development and Budget & Finance Committees have**
8 **reviewed the FY-07 Tohono O'odham Youth Council Budget, which is hereby**
9 **incorporated by this reference, and recommends approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approve**
11 **and authorize the carryover funds of \$63,770.76 and shall be the FY-07 Tohono**
12 **O'odham Nation Youth Council Budget as attached hereto.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council and Tohono O'odham**
14 **Nation's Officials, to wit; the Chairwoman and any designated Official are authorized**
15 **to execute this budget, provided however, that any amendment affecting the funds**
16 **or funding levels of this budget shall be submitted for further prior approval by the**
17 **Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
19 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,293.9 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 146.9 [08] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


