

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Nation Scholarship Fund Budget Carryover Funds and  
Modification/Amendment # 1)**

**RESOLUTION NO. 06-678**

1 **WHEREAS, in Resolution No.06-210, the Tohono O'odham Legislative Council approved the FY**  
2 **2007 Tohono O'odham Nation Scholarship Fund budget in the amount of**  
3 **\$5,556,539.60; and**

4 **WHEREAS, in Resolution No. 06-254 the Tohono O'odham Legislative Council approved**  
5 **supplemental funds in the amount of\$50,000.00 from General Revenue to assist with**  
6 **the costs of relocating the Tohono O'odham Nation Scholarship Fund modular; and**

7 **WHEREAS, the Tohono O'odham Nation Scholarship Fund has submitted for review and approval**  
8 **the proposed FY 2007 Budget Modification/Amendment # 1 to carry forward the**  
9 **remaining \$42,278.45 from the FY 2006 Supplemental funds approved in FY 2006 for**  
10 **a revised total of \$5,598,818.05; and**

11 **WHEREAS, the Tohono O'odham Nation Scholarship Fund has submitted for review and approval**  
12 **the proposed FY 2007 Budget Modification/Amendment # 1 to add line item 772.00**  
13 **Repair & Maint.-Building in the amount of\$35,918.95 and to increase line item 810.00**  
14 **Professional Services in the amount of \$6,359.50 for a revised total of \$8,359.50; and**

15 **WHEREAS, the Tohono O'odham Scholarship fund Budget Modification/Amendment #1 has been**  
16 **reviewed by the Human Resources Development Committee and the Budget and**  
17 **Finance Committee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
19 **approve and authorizes Carryover funds of \$42,278.45 for a revised total of**  
20 **\$5,598,818.05 for the Tohono O'odham Nation Scholarship Fund as attached hereto.**

21 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does hereby approve and**  
22 **authorizes the Tohono O'odham Nation Scholarship Fund Budget**  
23 **Modification/Amendment #1 to add a new line item 772.00 (Repair & Maint.-Building)**  
24 **in the amount of \$35,918.95 and increase line item 810.00 (Professional Services) in**  
25 **the amount of \$6,359.50 for a revised total of \$8,359.50.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation's Officials, to wit; the Chairwoman and any designated Official are authorized**  
28 **to negotiate and execute this budget, provided however, that any amendment**




