

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the Planning Department's Housing Rehabilitation Project Budget**  
**Amendment for Fiscal Year 2007)**

RESOLUTION NO. 06-679

1 **WHEREAS, the Legislative Council approved the three year funding request of \$9,405,649.93 by**  
2 **Resolution #01-661; and**

3 **WHEREAS, the Planning Department had presented a budget for FY-2007 in the amount of**  
4 **\$411,624.09 which was approved by the Housing Committee, Commerce Committee**  
5 **and Budget & Finance Committee of the Tohono O'odham Legislative Council; and**

6 **WHEREAS, upon review of the homes that are currently being built or renovated, we find the**  
7 **program will need to continue into Fiscal Year 2007; and**

8 **WHEREAS, the Housing Rehabilitation Project has carry-over dollars in the amount of \$2,000,000**  
9 **and the program is requesting an additional amount of \$295,103.04 which will come**  
10 **from surplus dollars, to complete the homes remaining on the former ICDBG list; and**

11 **WHEREAS, the budget has been presented to the Executive Committee, Housing Committee and**  
12 **Budget & Finance Committee for review and approval, whom recommend approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
14 **the FY 07 budget amendment for the amount of \$2,664,902.13, which consists of**  
15 **\$411,624.09 for FY07 and includes the carry over amount of \$2,000,000.00 from FY06**  
16 **and additional amount of \$295,103.04 from surplus funds, and attachments.**

17 **BE IT FINALLY RESOLVED, that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairwoman and any designated official to execute any and all contracts or**  
19 **agreements, provided that any amendments affecting the funds or funding level shall**  
20 **be submitted for further prior approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
22 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,242.3 FOR; 169.0**  
23 **AGAINST; 836.4 NOT VOTING; and 193.1[08] ABSENT, pursuant to the powers vested in the Council**  
24 **by Section 1 (d)(3)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
25 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**


