**(Authorization to expend FY2007 Indian Health Service Memorandum of Agreement**  
**carryover funds for the Solid Waste Management Program FY2007 budget 10-1097,**  
**in the amount of \$404,938.95)**

**RESOLUTION NO. 06-682**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**  
2 **between the Solid Waste Management Program and the Indian Health Service and**  
3 **budget 10-1097 through Resolution 97-041; and**

4 **WHEREAS, the Nation applied for and received \$1,934,000.00 from the Indian Health Service and**  
5 **the Federal Interagency Solid Waste Task Force for dump closures on the Nation; and**

6 **WHEREAS, the Nation's Grants and Contracts Office has identified carryover funds from the**  
7 **FY2006 Indian Health Service MOA budget 10-1097 in the amount of \$404,938.95; and**

8 **WHEREAS, the Solid Waste Management Program will submit a budget amount of \$404,938.95**  
9 **for FY2007; and**

10 **WHEREAS, the Solid Waste Management Program budget 10-1097 has been reviewed by the**  
11 **Legislative Natural Resources Committee and the Legislative Budget and Finance**  
12 **Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
14 **expenditure of FY2006 carryover funds in the amount of \$404,938.95, for the Solid**  
15 **Waste Management Program FY2007 budget 10-1097, retroactive from October 1,**  
16 **2006 through September 30, 2007, in accordance with the budget attached hereto.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**  
19 **to negotiate and execute the agreement, provided however, that any amendments**  
20 **affecting the funds or funding levels of the agreement shall be submitted for further**  
21 **approval.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
23 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
