

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to expend FY2007 Revenue in the amount of \$434,434.72 for the Solid Waste Management Program FY2007 budget 83-0003)

RESOLUTION NO. 06-683

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**
2 **Waste Management Program budget 83-0003 through Resolution 98-236; and**

3 **WHEREAS, the Solid Waste Management Program deposits any revenue into Bank of America**
4 **Account per resolution 05-557; and**

5 **WHEREAS, the Solid Waste Management Program has generated \$434,434.72 in revenue from**
6 **residential and commercial trash collection fees; and**

7 **WHEREAS, the Solid Waste Management Program will submit a budget amount of \$434,434.72**
8 **for FY2007; and**

9 **WHEREAS, the Solid Waste Management Program budget 83-0003 has been reviewed by the**
10 **Legislative Natural Resources Committee and the Legislative Budget and Finance**
11 **Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
13 **expenditure of FY2007 revenue in the amount of \$434,434.72 for the Solid Waste**
14 **Management Program FY2007 budget 83-0003, retroactive from October 1, 2006**
15 **through September 30, 2007, in accordance with the budget attached hereto.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Nation's Officials, to wit: the Chairwoman and any designated official are authorized**
18 **to negotiate and execute the agreement, provided however, that any amendments**
19 **affecting the funds or funding levels of the agreement shall be submitted for further**
20 **approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
22 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,657.0 FOR; -0-**
23 **AGAINST; 783.8 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


