12	NOW, THER	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the					
13		expenditure of FY2007 revenue in the amount of \$434,434.72 for the Solid Waste					
14		Management Program FY2007 budget 83-0003, retroactive from October 1, 2006					
15		through September 30, 2007, in accordance with the budget attached hereto.					
16	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham					
17		Nation's Officials, to wit: the Chairwoman and any designated official are authorized					
18		to negotiate and execute the agreement, provided however, that any amendments					
19		affecting the funds or funding levels of the agreement shall be submitted for further					
20		approval.

Day of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,657.0 FOR; -0-AGAINST; 783.8 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
