(Endorsing Congressional Candidate Mr. Jim Pederson for United States Senate
representing the State of Arizona)**

RESOLUTION NO. 06-685

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the electoral process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, the democratic candidate Mr. Jim Pederson has been supportive of tribal**
5 **governments and has demonstrated his respect for government-to-government**
6 **relationships between the federal government and tribal governments; and**

7 **WHEREAS, Mr. Jim Pederson has communicated his desire to maintain and enhance a**
8 **government-to-government relationship between the federal government and the**
9 **Tohono O'odham Nation if elected.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby endorses**
11 **congressional candidate Mr. Jim Pederson for United States Senate representing the**
12 **State of Arizona.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
14 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,767.1 FOR; 169.0**
15 **AGAINST; 504.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
19 **Stat. 984).**
