1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the electoral process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, the republican candidate and as current AZ House Representative Ms. Jennifer Burns**
5 **has been supportive of tribal governments and has demonstrated her respect for**
6 **government-to-government relationships between the state government and tribal**
7 **governments; and**

8 **WHEREAS, as a AZ House Representative, Ms Jennifer Burns has communicated her desire to**
9 **maintain and enhance a government-to-government relationship between the State**
10 **of Arizona and the Tohono O'odham Nation.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby endorses**
12 **Ms Jennifer Burns for Arizona State House of Representatives, Legislative District No.**
13 **25.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
15 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,850.8 FOR; 169.0**
16 **AGAINST; 421.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**
