

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsing Mr. Manuel Alvarez for Arizona State House of Representatives,
Legislative District No. 25)

RESOLUTION NO. 06-692

1 WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation
2 members participating in the electoral process as citizens of the United States of
3 America; and

4 WHEREAS, the democratic candidate and as a current AZ House Representative, Mr. Manuel
5 Alvarez has been supportive of tribal governments and has demonstrated his respect
6 for government-to-government relationships between the state government and
7 tribal governments; and

8 WHEREAS, as a AZ House Representative, Mr. Manuel Alvarez has communicated his desire to
9 maintain and enhance a government-to-government relationship between the State
10 of Arizona and the Tohono O'odham Nation if elected.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby endorses
12 Mr. Manuel Alvarez for Arizona State House of Representatives, Legislative District
13 No. 25.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
15 of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 731.25 FOR; 540.25
16 AGAINST; 1,169.3 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).
