

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsing Ms Rebecca Rios for Arizona State Senate, Legislative District No. 23)**

RESOLUTION NO. 06-693

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the electoral process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, the democratic candidate Ms Rebecca Rios has been supportive of tribal governments**
5 **and has demonstrated her respect for government-to-government relationships**
6 **between the state government and tribal governments; and**

7 **WHEREAS, Ms. Rebecca Rios has communicated her desire to maintain and enhance a**
8 **government-to-government relationship between the State of Arizona and the**
9 **Tohono O'odham Nation if elected.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby endorses**
11 **Ms Rebecca Rios for Arizona State Senate, Legislative District No. 23.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
13 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 847.0 FOR; 270.4**
14 **AGAINST; 1,323.4 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
16 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
18 **Stat. 984).**




