

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Supporting a "YES" vote on Proposition 302 in the 2006 State Elections)

RESOLUTION NO. 06-700

1 WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation  
2 members participating in the electoral process as citizens of the United States of  
3 America; and

4 WHEREAS, Proposition 302 Recommendation of the Commission on Salaries for elective state  
5 officers as to legislative salaries has been certified to the Secretary of State and is  
6 hereby submitted to the qualified electors for their approval or rejection and  
7 provides for an increase in the salaries of state legislators from \$24,000 to \$36,000  
8 per year; and

9 WHEREAS, a "yes" vote shall have the effect of raising the State Legislators' salaries to \$36,000  
10 per year.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports  
12 a "YES" vote on Proposition 302.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
14 of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,833.1 FOR; -0-  
15 AGAINST; 607.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
16 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
19 Stat. 984).


