

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with California Indian Legal Services)

RESOLUTION NO. 06-706

1 **WHEREAS, pursuant to Legislative Council Resolution 05-674, the Nation entered into an**
2 **Attorney Contract with California Indian Legal Services (the "Attorneys") for Fiscal**
3 **Year 2006, for the purpose of providing legal representation to protect the Nation's**
4 **interests under the Indian Child Welfare Act in connection with legal proceedings in**
5 **the State of California; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2006; and**

7 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
8 **proceedings; and**

9 **WHEREAS, the Attorney General has proposed an Attorney Contract with California Indian Legal**
10 **Services for Fiscal Year 2007, for the period October 1, 2006 to September 30, 2007, in**
11 **the amount of \$100,000, a copy of which is attached hereto; and**

12 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval by the**
13 **Legislative Council of an Attorney Contract with the Attorneys on such terms.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
16 **with California Indian Legal Services in the amount of \$100,000 for Fiscal Year**
17 **2007, for the period October 1, 2006 to September 30, 2007, in the form attached**
18 **hereto.**
- 19 **2. Funding for the Attorney Contract shall be provided from the operating budget**
20 **of the Office of Attorney General.**
- 21 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
22 **Contract.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


