

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Tohono O'odham Nation's Reburial Ceremony Budget - FY 07)**

RESOLUTION NO. 06-710

1 WHEREAS, the Tohono O'odham Nation uphold and respects the Culture, Traditions and  
2 Heritage from the Ancestral Past; and

3 WHEREAS, the Tohono O'odham Legislative Council acknowledged that there is need to  
4 provide funding to assist the Nation's Annual Reburial Ceremony which takes place  
5 in November of every year; and

6 WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 2000-275  
7 appropriating funds for the Cultural Center Museum; and

8 WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 03-487 establishing  
9 a budget of \$10,000 for the Reburial Ceremony in FY04, taking the funding from the  
10 Cultural Center Museum Reserve; and

11 WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 05-624 approving  
12 that the remaining funds from FY 05 (\$5,166.63) be carried over to provide funding  
13 for the Nation's Reburial Ceremony in FY06 and that any remaining funds from  
14 FY06 be carried over and expended until exhausted.

15 NOW, THEREFORE, BE IT RESOLVED THAT:

- 16 1. The Tohono O'odham Legislative Council approves the FY07 Nation Annual  
17 Reburial Ceremony Budget of \$2,203.07 of remaining funds from the FY06 carry  
18 over.
- 19 2. The Tohono O'odham Legislative Council approves and authorizes the  
20 expenditure of these funds according to the attached budget.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day  
22 of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-  
23 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
24 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).






