(Approving Budget Amendment #1 to Carryover \$293,399.00 from FY2006 24-1807 Initiative
Admin Accounting G/L Budget to FY2007 24-1807 Initiative Admin G/L Budget)

RESOLUTION NO. 06-712

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2007 Initiative Admin**
2 **Accounting G/L Budget pursuant to Tohono O'odham Legislative Council Resolution**
3 **No. 06-210; and**

4 **WHEREAS, line item 830 AUDIT is added to the FY07 Initiative Admin Accounting G/L Budget**
5 **and reflects a carryover amount of \$293,399.00 for costs associated with the minor**
6 **account audit for a total budget amount of \$345,237.74; and**

7 **WHEREAS, carryover funds from the FY2006 budget to the FY2007 have been authorized by the**
8 **Tohono O'odham Legislative Council per Resolution #06-545; and**

9 **WHEREAS, the FY07 Initiative Admin Accounting G/L 24-1807 Budget Amendment #1 has been**
10 **reviewed by the Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 12 **1. Approves the addition of line item 830 AUDIT to the FY07 Initiative Admin**
13 **Accounting G/L budget 24-1807 for costs associated with the minor account**
14 **audit.**
- 15 **2. The Tohono O'odham Legislative Council re-authorizes to carryover from**
16 **FY2006 Initiative Admin Accounting G/L Budget the amount of \$293,399.00 to**
17 **the FY2007 Initiative Admin Accounting G/L Budget for a total budget amount**
18 **of \$345,237.74 to continue and complete the minor account audit pursuant to**
19 **Tohono O'odham Legislative Council Resolution #06-545.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Officials, to wit: the Chairwoman and any designated official are**
22 **authorized to administer the budget, provided however, that any amendments**
23 **affecting the funds or funding levels of the budget shall be submitted for further**
24 **prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
26 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
