RESOLUTION NO. 06-726

1 **WHEREAS, the Gu-Vo District Governing Council did receive the allocated amount of**
2 **\$1,094,690.94 from the Tohono O'odham Nation Gaming Revenue Distributions**
3 **given out to all 11 Districts in equal amounts; and**

4 **WHEREAS, the total amount that the Gu-Vo District was allocated is \$1,094,690.94 for the FY**
5 **2006/2007; and**

6 **WHEREAS, the Gu-Vo District did present the FY 2006- 2007 Budgets to its membership,**
7 **Administration, Communities, District Budget & Finance Committee and also to the**
8 **Governing Council for review and approval; and**

9 **WHEREAS, the Gu-VO District Governing Council has approved the Budget amount for each**
10 **Community and Administration by GV06-121 and they are as follows:**

13	3. Ali Chugk Community	\$135,000.00

17 **WHEREAS, the Gu-Vo District did present to Tohono O'odham Legislative Budget and Finance**
18 **Committee for review and recommendation; and**

19 **WHEREAS, the Tohono O'odham Legislative Budget and Finance Committee did review the Gu-**
20 **Vo 07 Budget and recommends it's approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approve the Gu-Vo District FY 2006-2007 Budget in the amount of \$1,094.690.94 and**
23 **as per attached Budgets for the District Administration and Communities.**

24 **BE IT FURTHER RESOLVED that the Gu-Vo District Fiscal Year 2006 - 2007 Budget shall be**
25 **retroactive to October 01, 2006**

26 **BE IT FINALLY RESOLVED that any changes in the funding or funding levels of the attached budget**
27 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
28 **Council.**


