

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution #06-201, "FY 2007 Title III B, C-1, C-2, Nutrition Services Incentive Program (NSIP), E, Case Management and Health Promotion Budgets")

RESOLUTION NO. 06-728

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution Number 06- 201 on**
2 **March 22, 2006 approving the Senior Services Administration on Aging (AoA) FY07**
3 **Title III budgets to continue Nutrition and Support services for the Elders and**
4 **Caregivers of the Tohono O'odham Nation; and**

5 **WHEREAS, the Senior Services AoA FY07 Title III are amended to reflect the actual grant awards**
6 **as per Notice of Grant Award (NOGA); and**

7 **WHEREAS, the Title III B FY07 budget is amended to reflect the *decrease* in funding from**
8 **\$53,457.00 to \$31,920.00 (increase of \$21,537.00); and**

9 **WHEREAS, the Title III C-1 FY07 budget is amended to reflect the *increase* in funding from**
10 **\$65,864.00 to \$84,808.00 (increase of \$18,944.00); and**

11 **WHEREAS, the Title III C-2 FY07 budget is amended to reflect the *decrease* in funding from**
12 **\$36,793.00 to \$33,674.00 (decrease of \$3,119.00); and**

13 **WHEREAS, the Title III Nutrition Service Incentive Program (NSIP) budget is amended to reflect**
14 **the *decrease* in funding from \$10,962.00 to \$7,555.00 (decrease of 3,407.00); and**

15 **WHEREAS, the Title III E budget is amended to reflect the *decrease* in funding from \$32,115.00**
16 **to \$28,314.00 (decrease of \$3,801.00); and**

17 **WHEREAS, the Title III Case Management budget is amended to *zero out* the budget from**
18 **\$4,837.00 to \$0.00 (decrease of \$4,837.00) as this budget was not funded; and**

19 **WHEREAS, the Title III D – Health Promotion budget is amended to reflect the *decrease* in**
20 **funding from \$17,698.00 to \$8,358.00 (Decrease of \$9,340.00).**

21 **NOW THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **approves:**

23 **1. The Title III B FY07 budget amendment to *decrease* the funds from \$53,457.00 to**
24 **\$31,920.00 (decrease of \$21,537.00).**

25 **2. The Title III C-1 FY07 budget amendment to *increase* the funds from \$65,864.00**
26 **to \$84,808.00 (increase of \$18,944.00).**

27 **3. The Title III C-2 FY07 budget amendment to *decrease* the funds from \$36,793.00**
28 **to \$33,674.00 (decrease of \$3,119.00).**
