

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution # 06-190, "FY 2007 Title VI Part A, Part C - Native American Family
Caregiver Support and Nutrition Services Incentive Program (NSIP) Budgets")**

RESOLUTION NO. 06-729

1 **WHEREAS, the Tohono O'odham Legislative did pass Resolution Number 06-190 on March 21,**
2 **2006 approving the Senior Services Administration on Aging (AoA) Title VI grants,**
3 **to continue Nutrition and Support services for the Elders and Caregivers of the**
4 **Tohono O'odham Nation; and**

5 **WHEREAS, the Senior Services FY07 AoA Tile VI budgets are amended to reflect the actual grant**
6 **awards as per attached; and**

7 **WHEREAS, the FY07 Title VI Part A Program budget is amended to reflect the *decrease* in**
8 **funding from \$136,940.00 to \$135,290.00 (decrease of \$1,650.00); and**

9 **WHEREAS, the FY07 Title VI Part C - Native American Family Caregiver Support Program**
10 **Budget is amended to reflect the *decrease* in funding from \$51,510.00 to \$50,820.00**
11 **(decrease of \$690.00); and**

12 **WHEREAS, the FY07 Title VI Nutrition Service Incentive Program (NSIP) budget is amended to**
13 **reflect the *increase* in funding from \$7,983.00 to \$8,921.00 (increase of \$938.00).**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **approves:**

- 16 **1. To amend Resolution Number 06-190 approving the Senior Services FY07 AoA**
17 **Title VI budgets.**
- 18 **2. The FY07 Title VI Part A Program budget amendment to *decrease* from**
19 **\$136,940.00 to \$135,290.00 (decrease of \$1,650.00).**
- 20 **3. The FY07 Title VI Part C - Native American Family Caregiver Support Program**
21 **budget amendment to *decrease* from \$51,510.00 to \$50,820.00 (decrease of**
22 **\$690.00).**
- 23 **4. The FY07 Title VI Nutrition Service Incentive Program (NSIP) budget**
24 **amendment to *increase* from \$7,983.00 to \$8,921.00 (Increase of \$938.00) in**
25 **accords with the Notification of Grant Award.**
- 26 **5. The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
27 **authorized to negotiate and execute the grant, provided however, that any**
28 **amendments affecting the funding or funding levels of this contract shall be**
29 **submitted for further prior approval by this Legislative Council.**
