**RESOLUTION NO. 06-730**

1 **WHEREAS, by Resolution No. 06-212, the Legislative Council approved the FY 2007 Bureau of**  
2 **Indian Affairs (BIA) Budgets and Annual Funding Agreement under a P.L. 93-638**  
3 **Master Contract; and**

4 **WHEREAS, the Legislative Council approved the FY 2007 BIA ICWA - Family Preservation budget**  
5 **in the following amounts:**

6 **P. ICWA - Family Preservation: Base Allocation = \$157,098.00, Indirect Cost =**  
7 **\$28,246.22, Total = \$185,344.22; and**

8 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare Services,**  
9 **has developed and obtained committee approval to utilize BIA Carry-Forward**  
10 **Savings for the FY 2007 BIA ICWA - Family Preservation Savings Budget attached**  
11 **and incorporated by this reference, to be effective October 1, 2006 through**  
12 **September 30, 2007, and requests authorization to expend funds in the following**  
13 **amounts:**

14 **P. ICWA - Family Preservation Savings: Carry-Forward Savings = \$40,550.97,**  
15 **Indirect Cost = \$7,842.56, Total = \$48,393.53.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **approve and authorize the Executive Branch to expend funds from BIA Carry-**  
18 **Forward Savings for the FY 2007 BIA ICWA - Family Preservation Savings Budget**  
19 **attached, effective October 1, 2006 through September 30, 2007, in the following**  
20 **amounts:**

21 **P. ICWA - Family Preservation Savings: Carry-Forward Savings = \$40,550.97,**  
22 **Indirect Cost = \$7,842.56, Total = \$48,393.53.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman and**  
24 **any designated official are hereby authorized to negotiate, execute and expend the**  
25 **grant, provided however, that any amendments affecting the funding levels of the**  
26 **grant shall be submitted for further prior approval.**


