

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Modifying Consolidated Healthy O'odham Promotion Program FY 2007 Budget  
(October 1, 2006 – September 30, 2007))**

**RESOLUTION NO. 06-732**

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**  
2 **through FY 2009 with a base budget of \$1,929,827.00 and carryover funding of**  
3 **\$3,529,100.56 for a total budget of \$5,458,927.56; and**

4 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved**  
5 **the establishment of the Community Based Diabetes Prevention Program, funded**  
6 **by the Special Diabetes Programs for Indians, authorized by the Balanced Budget**  
7 **Act of 1997; and**

8 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**  
9 **the name change of the Community Based Diabetes Prevention Program to the**  
10 **Healthy O'odham Promotion Program; and**

11 **WHEREAS, the Tohono O'odham Department of Human Services is requesting the Fiscal Year**  
12 **2007 base budget of \$1,929,827.00 and carryover funding of \$3,529,100.56 for a total**  
13 **budget of \$5,458,927.56.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 15 **1. Approves the Division of Health Promotion Program Fiscal Year 2007 base**  
16 **budget of \$1,929,827.00 and carryover funding of \$3,529,100.56 for a total**  
17 **budget of \$5,458,927.56.**
- 18 **2. Approves the addition of the project administrator position with salary and**  
19 **fringe benefits retroactive to October 1, 2006.**
- 20 **3. The Tohono O'odham Nation Officials, to wit: the Chairwoman and any**  
21 **designated Official are hereby authorized to negotiate and execute the grant**  
22 **and expend funds associated with this budget.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day**  
24 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 2,271.8 FOR; -0-**  
25 **AGAINST; 169.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**




