

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Management of Health/Modular and Master Planning Development
Modification #1 for Fiscal Year 2007)**

RESOLUTION NO. 06-734

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 159 approved the FY 2007**
2 **Budget Management of Health/Modular and Master Planning Development**
3 **(MOH/MMPD);and**

4 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 06-395 approved FY 2006**
5 **Management of Health/Modular and Master Planning Development which included**
6 **funding for a cost-shared Project Administrator position; and**

7 **WHEREAS, the Project Administrator is needed to address the Department of Health and**
8 **Human Services' Modular Projects and building renovations; and**

9 **WHEREAS, the Project Administrator position salary is covered as follows: MOH/MMPD at 50%,**
10 **Behavioral Health Division at 25%, and H.O.P.P. Division at 25%; and**

11 **WHEREAS, the 2007 Management of Health/Modular and Master planning Development**
12 **budget needs to be modified to include the Project Administrator position; and**

13 **WHEREAS, the Project Administrator position salary and fringe benefits needs to be**
14 **retroactive to October 1, 2006.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve:**

- 17 **1. The FY 2007 Management of Health/Modular and Master Planning Modification**
18 **#1 to add Project Administrator position at 50% of the salary (cost-share with**
19 **Behavioral Health Division at 25% and H.O.P.P. at 25%).**
- 20 **2. Project Administrator position is needed to address the Department of Health**
21 **and Human Services' Modular Projects and building renovations.**
- 22 **3. The FY 2007 Management of Health/Modular and Master Planning Modification**
23 **#1 to be retroactive to October 1, 2006.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation's Official, to wit: the Chairwoman, and any designated official are authorized**
26 **to negotiate and execute the grant, provided however, that any amendments**
27 **affecting the funds or funding levels of the grant shall be submitted for further**
28 **prior approval by the Tohono O'odham Legislative Council.**

5 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).
