

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY07 Budget for the HICKIWAN District Administration of \$846,852.52
from Gaming Distribution / Host Share Allocation for the HICKIWAN District)**

RESOLUTION NO. 06-735

1 **WHEREAS, the HICKIWAN District Administration presented their FY07 Budget to the Tohono**
2 **O'odham Legislative Council for approval in the amount of \$846,852.52 for**
3 **Administrative Operations from Gaming Distribution / Host Share of \$1,108,092.47;**
4 **and**

5 **WHEREAS, the HICKIWAN District Council approved a \$3.00 per hour increase to the District's**
6 **senior employees; and**


7 **WHEREAS, the seven communities (Schuchulikg, Hodai Shon Wo'o, South HICKIWAN, Stoa-Bith,**
8 **Vaya Chin, Ventana, and Gehakah) will receive \$37,319.99 per community with a**
9 **total of \$261,239.95 which will brought forth at a future date for approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the HICKIWAN District Administration FY07 Budget retroactive to October 01, 2006**
12 **in the amount \$846,852.52 for operations including a \$3.00 per hour increase for its**
13 **senior employees from Gaming Distribution/Host Share Allocation.**

14 **BE IT FINALLY RESOLVED that the seven communities (Schuchulikg, Hodai Shon Wo'o, South**
15 **HICKIWAN, Stoa Bith, Vaya Chin, Ventana, and Gehakah) FY07 Budgets in the amount**
16 **of \$37,319.99 per community with a total of \$261,239.95 will be presented to the**
17 **Tohono O'odham Legislative Council at a future date and no funds will be expended**
18 **until a resolution has been approved.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
20 **of OCTOBER, 2006 at a meeting at which a quorum was present with a vote of 1,436.1 FOR; -0-**
21 **AGAINST; 835.7 NOT VOTING; and 169.0 [08] ABSENT, pursuant to the powers vested in the Council**
22 **by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




