

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Legislative Order No. 05-300, "Certification of Legislative Committee  
Officers," to Certify Rules Chairperson)**

**LEGISLATIVE ORDER NO. 06-745**

1 **WHEREAS, on September 19, 2006, Tohono O'odham Legislative Council Representative**  
2 **Cynthia Manuel was elected as the Legislative Council Vice Chairperson pursuant**  
3 **to Legislative Order No. 06-645; and**

4 **WHEREAS, prior to her election, Representative Manuel served as Chairperson of the**  
5 **Legislative Rules Committee; that office therefore became vacant effective**  
6 **September 19, 2006; and**

7 **WHEREAS, individual Legislative Council standing committees are empowered to caucus and**  
8 **elect committee officers (Legislative Rules of the Tohono O'odham Legislative**  
9 **Council, Article XII, Section 3.J.); and**

10 **WHEREAS, the Rules Committee did caucus and elect Representative Darlene Andrew as its**  
11 **Chairperson.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
13 **certifies Representative Darlene Andrew as Chairperson of the Rules Committee**  
14 **effective immediately.**

15 **BE IT FINALLY ORDERED that Legislative Order No. 05-300, "Certification of Legislative Committee**  
16 **Officers," is hereby amended only to the extent that Representative Darlene Andrew**  
17 **is certified as the Chairperson of the Rules Committee.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day of**  
19 **NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
21 **VI Section 1 (a)&(b) the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
