

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Grant Award # 04-01-N06024 in the amount of \$17,550.00 and Approving the
KOHN Public Telecommunication Facilities Program Interconnection Grant Budget)

RESOLUTION NO. 06-753

1 **WHEREAS, the Tohono O'odham Nation on behalf KOHN, a non-commercial educational radio**
2 **station licensed to the Nation, submitted an application to the Public**
3 **Telecommunication Facilities Program (PTFP) for funding to purchase and install**
4 **satellite equipment; and**

5 **WHEREAS, installation of satellite equipment will enable KOHN to interconnect with other**
6 **Native owned stations and to acquire nationally available programming for**
7 **broadcast to the Nation's membership; and**

8 **WHEREAS, the Nation through KOHN has been notified that PTFP has awarded \$17,550.00**
9 **representing 75% of the total project cost of \$23,400.00; and**

10 **WHEREAS, the grant requires a 25% match, \$5,850.00, from KOHN for which provisions has**
11 **been made in the FY 2007 operating budget of KOHN; and**

12 **WHEREAS, KOHN has prepared and submitted for internal review by the Executive Branch,**
13 **Culture Preservation Committee and the Budget and Finance Committee the**
14 **attached budget to facilitate the expenditure of the award.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
16 **accepts the grant award #04-01-N06024 in the amount of \$17,550.00 from the Public**
17 **Telephone Facilities Program on behalf of KOHN for the purchase and installation**
18 **of satellite equipment; for the grant period October 1, 2006 through September 30,**
19 **2007; and that the attached budget is approved and authorized to be expended for**
20 **the purposes described.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation's Officials to-wit: the Chairwoman, and any designated official, are**
23 **authorized to execute the grant, provided however, that any amendments affecting**
24 **the funds or funding levels of the grant shall be submitted for further prior**
25 **approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH. Day**
27 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
28 **AGAINST; -0-NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**


