2006 for a Total of \$299,670.00 #2006HEWX0010 with a match of \$99,890.00)

RESOLUTION NO. 06-755

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has successfully received**
2 **an award with the Community Oriented Policing services (COPS) Tribal Resource**
3 **Grant Program (TRGP) Equipment award, funded through the U.S Department of**
4 **Justice (USDOJ) for the project amount of \$299,670.00 with a matching share of**
5 **\$99,890.00 to be identified for a total of \$399,560.00 under grant award number**
6 **2006HEWX0010; and**

7 **WHEREAS, TONPD requests the Tohono O'odham Legislative Council to approve the**
8 **acceptance of this grant and authorize the grant in the amount of \$399,560.00.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
10 **accepts and authorizes the implementation of this COPS-TRGP grant**
11 **#2006HEWX0010 with the effective date of August 1, 2006 through July 31, 2008; and**

12 **BE IT FURTHER RESOLVED that no funding from the grant shall be expended until a budget is**
13 **presented and approved by the Tohono O'odham Legislative Council including a**
14 **match share of \$99,890.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairwoman is**
16 **authorized to accept and execute any documentation associated with exercising the**
17 **acceptance and implementation of agreement affecting the funding or funding**
18 **levels of this grant shall be submitted for approval to the Tohono O'odham**
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH Day**
21 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,061.3 FOR; -0-**
22 **AGAINST; 379.5 NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


