13	WHEREAS,	the Administration for Children and Families requests authorization to expend
14		funds  from  October  1,2006  through  September  30,2007  of  this  grant  in  the  amount
15		of \$138,371.00.

21		2. Approves the Family Violence Prevention and Services budget and authorizes
22		the Department of Health and Human Services community Health Division to
23		expend such funds retro active to October 1, 2006 through September 30, 2007
24		in the amount \$138,371.00.
