

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting and Approving the FY 07 Family Violence Prevention Services Grant)**

**RESOLUTION NO. 06-757**

- 1 **WHEREAS, prevention of injuries is a health priority for the Tohono O'odham Nation; and**  
2 **WHEREAS, domestic violence is a source of injuries for the individuals and family members;**  
3 **and**  
4 **WHEREAS, the Domestic Violence Program of the Health and Human Services-Community**  
5 **Health Division and the Domestic Violence Coalition is working to raise awareness**  
6 **of domestic violence and continue the development of services for domestic**  
7 **violence victims and their families; and**  
8 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services received**  
9 **a Family Violence Prevention and Services grant in FY-2006 for a total of**  
10 **\$144,482.00; and**  
11 **WHEREAS, the grant has expenditure period effective, May 10, 2006 and ending September 30,**  
12 **2008; and**  
13 **WHEREAS, the Administration for Children and Families requests authorization to expend**  
14 **funds from October 1, 2006 through September 30, 2007 of this grant in the amount**  
15 **of \$138,371.00.**  
16 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**  
17 **1. Accepts and approves the grant award G-06PCAZFVPS DHHS/ACF Family**  
18 **Violence Prevention and Services Budget effective May 10, 2006 and ending**  
19 **September 30, 2008 and authorizes the expenditure of funds in the amount of**  
20 **\$138,371.00.**  
21 **2. Approves the Family Violence Prevention and Services budget and authorizes**  
22 **the Department of Health and Human Services community Health Division to**  
23 **expend such funds retro active to October 1, 2006 through September 30, 2007**  
24 **in the amount \$138,371.00.**  
25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation officials, to wit: the Chairwoman and any designated official are hereby**  
27 **authorized to negotiate and execute the grant, provided however, that any**  
28 **amendments affecting the funds or funding levels of the grant shall be submitted**  
29 **for further prior approval by the Tohono O'odham Legislative Council.**






