

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Nicholas Lewis to the Election Board for the Five-Year Term Ending July 31, 2011)

RESOLUTION NO. 06-768

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint**
2 **members of the Tohono O'odham Election Board pursuant to Section 1(B) of Article**
3 **II of Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"),**
4 **which states, "Members of the Election Board shall be appointed by the Tohono**
5 **O'odham Council for terms of five years, or until their successors are appointed and**
6 **qualified"; and**

7 **WHEREAS, the Election Ordinance further requires "that appointments to the board shall be**
8 **made in such a way and for such terms that their terms shall be staggered so that**
9 **the term of office of only one member will end in any single year."; and**

10 **WHEREAS, effective July 31, 2006, Election Board Member Nicholas Lewis's term did expire and**
11 **he continues to serve as a Board member until his successor is appointed; and**

12 **WHEREAS, the Rules Committee, having legislative oversight over the Election Board, has**
13 **interviewed qualified bilingual members of the Nation to fill this seat on the**
14 **Election Board; and**

15 **WHEREAS, the Rules Committee has reported its findings concerning this appointment to the**
16 **Legislative Council and has recommended that Nicholas Lewis be re-appointed to**
17 **the Election Board for the five-year term ending July 31, 2011.**

18 **NOW, THEREFORE, BE IT RESOLVED, the Legislative Council hereby appoints Nicholas**
19 **Lewis as a member of the Election Board for the five-year term ending July 31, 2011.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day**
21 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 2,078.0 FOR; -0-**
22 **AGAINST; 362.8 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (g) of Article VI and Section (7) of Article X of the Constitution of the Tohono O'Odham**
24 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
25 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
26 **of the Act of June 18, 1934 (48 Stat. 984).**
