

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Amendment #1 for Baboquivari District Administration, Choulic Community and Topawa Community, Utilizing F.Y. 2005 Carryover Monies)**

RESOLUTION NO. 06-769

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on**  
2 **November 6, 2006, of which a quorum was present; and**

3 **WHEREAS, the District Administration, Choulic Community and Topawa Community presented**  
4 **their 2007 budget amendment #1, in the amount of Administration - \$79,159.24,**  
5 **Choulic-\$40,342.37, and Topawa- \$73,727.16; and**

6 **WHEREAS, the amendments (as attached hereto) will increase the original budget for**  
7 **Administration of \$437,876.38 to \$517,035.62, original budget for Choulic of**  
8 **\$109,469.09 to \$149,811.46, original budget for Topawa of \$109,469.09 to**  
9 **\$183,196.25; and**

10 **WHEREAS, the amendments will utilize F.Y. 2005 carryover monies for Administration,**  
11 **Choulic, and Topawa and will also deplete funds for F.Y. carryover.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves budget**  
13 **amendment #1 for District Administration original 2007 budget of \$437,876.38 to**  
14 **\$517,035.62, budget amendment #1 for Choulic Community original 2007 budget of**  
15 **\$109,469.09 to \$149,811.46, and original budget amendment #1 for Topawa**  
16 **Community 2007 budget of \$109,469.09 to \$183,196.25.**

17 **BE IT FINALLY RESOLVED, that any amendments affecting the funding levels shall be submitted**  
18 **for further prior approval by this Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>. Day**  
20 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,164.95 FOR; 867.5**  
21 **AGAINST; 408.35 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
