1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY06 Solid Waste**
2 **Management Program Household Hazardous Waste budget 11-5019 with Resolution**
3 **05-561 in the amount of \$41,500; and**

4 **WHEREAS, the Nation's Grants and Contracts Office has calculated \$38,254.94 in carry forward**
5 **funds from the FY06 Solid Waste Management Program Household Hazardous**
6 **budget 11-5019 and has allocated \$12,000 in additional US Environmental**
7 **Protection Agency funds for the FY07 Household Hazardous Waste budget 00-0000**
8 **for a total amount of \$50,254.94; and**

9 **WHEREAS, the FY07 Solid Waste Management Program Household Hazardous Waste budget**
10 **00-0000 has been reviewed by the Tohono O'odham Legislative Natural Resources**
11 **Committee and the Budget and Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 13 **1. Authorizes the expenditure of \$38,254.94 in carry forward funds from the**
14 **FY06 Solid Waste Management Program Household Hazardous Waste budget**
15 **11-5019 for the FY07 Solid Waste Management Program Household**
16 **Hazardous Waste budget 00-0000.**
- 17 **2. Accepts and authorizes the expenditure of \$12,000 in additional US**
18 **Environmental Protection Agency funds for the FY07 Solid Waste**
19 **Management Program Household Hazardous Waste budget 00-0000, for a**
20 **total amount of \$50,254.94, in accordance with the budget attached hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation's Officials, to wit: the Chairwoman and any designated official are**
23 **authorized to negotiate and administer this budget, provided however, that any**
24 **amendments affecting the funds or funding levels of the budget shall be submitted**
25 **for further prior approval.**




