

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving San Xavier District's FY 2007 Budget)**

RESOLUTION NO. 06-774

1 **WHEREAS, the San Xavier District (District) Council proposed to its members a budget amount**  
2 **of \$6,643,123.99 which was reviewed and approved by majority vote of the District**  
3 **members present at the Special District Community meeting held on November 4,**  
4 **2006; and**

5 **WHEREAS, the District Council subsequently approved its fiscal year 2007 budget as approved**  
6 **by District members pursuant to Res. No. SXDC 11-06-03, determining that the budget**  
7 **components are essential to meeting the needs of its membership; and**

8 **WHEREAS, the District intends to utilize its gaming revenues, and funds due to the District from**  
9 **the Bureau of Indian Affairs to meet the projected budget amount outlined in the**  
10 **District's fiscal year 2007 budget; and**

11 **WHEREAS, on November 16, 2006 the Tohono O'odham Legislative Council's Budget & Finance**  
12 **Committee met with District officials to review the District's fiscal year 2007 budget;**  
13 **and**

14 **WHEREAS, the Tohono O'odham Legislative Council's Budget & Finance Committee approved by**  
15 **consensus the District's FY 2007 budget, recommending that it be put forward for**  
16 **review and approval by the Tohono O'odham Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the**  
18 **authority granted under the Tohono O'odham Constitution Article IX, Section 7,**  
19 **approves San Xavier District's budget for fiscal year 2007 in the amount of**  
20 **\$6,643,123.99.**

21 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels shall be**  
22 **submitted for further prior approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day**  
24 **of NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,683.4 FOR; -0-**  
25 **AGAINST; 757.4 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
