

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Legislative Order No. 06-772, "Setting November 29, 2006 Special Session to Review  
the Tribal Trust Claims Based Upon Arthur Anderson Trust Fund Reconciliation Report")**

**LEGISLATIVE ORDER NO. 06-776**

1 **WHEREAS, according to the Legislative Rules of the Tohono O'odham Legislative Council**  
2 **("Legislative Rules"), Article I, Section 1.D.2., "The Legislative Council may, by**  
3 **majority vote, call for a special session."; and**

4 **WHEREAS, on November 17, 2006, the Legislative Council passed Legislative Order No. 06-772**  
5 **and thereby set a special session for November 29, 2006 at 9:00 a.m. to address tribal**  
6 **trust claims based upon the Arthur Anderson Trust Fund Reconciliation Report to**  
7 **be presented by Keith Harper and Jacob Moore; and**

8 **WHEREAS, Article I, Section 1D.5. of the Legislative Rules provides that a "special session**  
9 **agenda shall be limited to the purpose for which the session is originally called and**  
10 **shall not be amended"; and**

11 **WHEREAS, it is in the best interest of the Nation to include additional agenda items in the**  
12 **special session agenda.**

13 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
14 **(1) suspends Article I, Section 1.D.5. of the Legislative Rules for the limited purpose**  
15 **of adding additional agenda items to the Legislative Council's November 29, 2006**  
16 **special session and (2) amends the special session agenda for November 29, 2006 to**  
17 **add the following agenda items: (a) BIA land-into-trust regulation comments, (b)**  
18 **gaming device operating rights transfer agreement, (c) minors' third per capita**  
19 **payment certification, and (d) other budgets.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day of**  
21 **NOVEMBER, 2006 at a meeting at which a quorum was present with a vote of 1,604.0 FOR; 707.45**  
22 **AGAINST; 129.35 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
