8	WHEREAS, during the November 29, 2006 Special Session, the Chairwoman presented to the
9	Legislative Council her justification in vetoing Resolution No. 06-748, a copy of which
10	is attached hereto; and
11	WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after
12	consideration, again voted to pass Resolution No. 06-748.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
14	override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance
15	with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham
16	Nation.
17	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 29^{TH} .
18	day of NOVEMBER, 2006 at a meeting at which a quorum was present, and by a vote of 1,845.3 FOR;
19	93.35 AGAINST;502.15 NOT VOTING; and [03] ABSENT, was passed by a vote of two-thirds (2/3)
20	[1,292.43] of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono
